# A Religious Gmina or a Nation Gmina

If the Jewish Gminas in Poland are not up to the task, it is because the groups, which have led it thus far, have not understood the proper role of a Gmina as an organ of the Jewish National Self-Government.

Although formal regulations have given these institutions an exclusively religious character, the actual compositions of gminas' councils and boards of management give them their proper appearance and development of the gmina system.

Zionist groups, completely absorbed in Palestine work, have neglected – we must say with regret – diaspora problems.

opportunistic elements, easily
susceptible to external pressure,
ruling these institutions at their
own "whim" for the petty interests
of their clique and its adherents.

It is high time for the Jewish community to realise that "apoliticality" is not a licence for the holding of communal positions in today's responsible times.

In these difficult moments, when the fate of Jewry is being decided, we must demand, from the people who claim to lead Jewry, a clear ideological physiognomy and appropriate communal sophistication.

The Revisionist Organisation, as a national and people's movement par excellence, is now faced with the need to go the elections under the slogan of nationalising the "kehilla", in accordance with the principles of Herzl Zionism.

Revisionism calls for the activation of the broad Jewish masses for the activity of Jewish revival, for the radical reconstruction of the foundations of the abnormal existence in all diaspora stages.

We are a nation, not a religious community, and that is why the bodies of our self-government/ gminas, must have a national character.

The gmina must be rebuilt so that, from a religious institution, it becomes something representing Judaism in a given locality.

We do not deny the religious tasks of the gmina.

We not only have a positive attitude towards religion, but we consider the sanctity of the Torah to be indispensable canon for national revival, as clearly stated by the N.O.S. Constituent Assembly in Vienna.

There remains a whole, huge social and cultural area, encompassed in a national spirit – e.g., expansion of Jewish education, especially vocational education for young people preparing for emigration, support for physical education, etc.

However, we are of the opinion that, in the current condition of aggression against the Jewish religion and nation, we need a **central** representative factor in every city and town. Local Jewish gminas are suitable for this role and, at a further stage, for the development of the **National Association of Jewish Communities**.

The only point is that these representations should carry high the banner of **Jewish honour** and that the following should be alien to them: submitting and yielding to

opponents, resignation, pettiness

And that is why it is necessary to eliminate the elements which have reduced the authority of gmina councils and that we permit people, with a declared ideological face, to speak, people whose beliefs and previous activities guarantee that they are worthy to hold positions in Jewish national self-governing bodies.

If our national parties, claiming a leading role in our lives, will abandon their narrow party interests and constant fight, it will be possible to create platforms of cooperation and ideological competition, within the gmina territory, for the benefit of the Jewish masses.

## It is all the fault of the Jews

From the meeting of the Assoc. of Polish Merchants

An extraordinary meeting of the Częstochowa Association of Polish Merchants, was held on Sunday during which, among other, mgr. Topolnicki, from Warsaw, delivered an extensive lecture, from which we quote (according to "Goniec") a passage of particular interest to us Jews:

"There used to be a belief among us, said Mr Topolnicki, that Poles were supposedly unsuited for trade and this suggestion was maintained by the Jews, our fierce competitors, in order to exclude us from trade and also by teaching us their evil, dishonest methods.

"Therefore, we must make Christian trade as transparent as other areas of work. Then everyone will treat the merchant differently – as a community worker.

"After discussing the technical and organisational aspects of trade in setting up stores and the resultant difficulties, the speaker outlined the benefits that merchants gained from establishing Christian wholesale stores and interest-free funds, freeing them from the hands of Jewish wholesalers.

"Other issues to look out for include unfair competition, overselling, stealing from competitors, gossiping and humiliating a competitor and not respecting a merchant's time. These should have no place in the career and profession of an honest Christian merchant."

We believe that Mr Topolnicki's attacks do not require special comments – they are merely a reflection of the slogans proclaimed by Jewish-hating circles.

Józef Dudek, Aniela Wieczorek and Stanisław Wojyasik were given six months suspended sentences, Zygmunt Januszek was sentenced 8 months, not suspended. Marja Turen was found not guilty.

#### Częstochowa sports week

In the last week, serious changes have taken place in Częstochowa sports, which may become decisive in the further development of sports in Czestochowa.

Firstly, the Advisory Committee to the Kielce OZPN Commissioner is Mr Krassowski, following the resignation of Mr Kanus, who could not agree with the views of Mr Krassowski. The new people are Mr Szmekiel, former vice-president of the Kielce OZPN and Mr N. Scherer, former president of the Kielce OXFN.

Mr Szmekiel, together with Cpt. Wołowiec, will run the W.G. and Kielce Prov. Agencies, while Mr Scherer with run finance and the secretariat.

Commissioner Krassowski told us that, with such a selected team of people, the messy relations in the Kielce District football can be repaired.

Following the liquidation of the Częstochowa-Zaglębie boxing sub-district in Sosnowiec, which had brutally alienated both the Częstochowa clubs and the Śł. OZB, serious people, who care about the development of boxing, last Saturday gathered for a joint meeting at the Brigade's premises, where they decided to establish the Kielce OZB Organising Committee, aimed at setting up a boxing district covering activities in the entire Kielce Province.

The committee comprises Capt. Wolowiec, Eng. Grzywa, Messrs. Szor and Hejm on behalf of the Brigade, Dr Asz, Eng. Wajnsztok, Messrs. Scherer and Wajs on behalf of Makkabi. The working of the Organising Committee is moving a fast pace.

Last Sunday, in Częstochowa, in front of representatives of city authorities and government, a heavy struggle took place between the local Brigade team and Łódź's Ł.T.G.S. for entry into the State Leazue.

Brigade deservedly won the game 1:0 (1:0), showing a great zeal and boundless ambition. The heroes were Krzyk, Głogowski, Głowacki and Bień for Brigade and t.T.G.S. goalkeeper Lass.

At the same time, while Brigade was laying a foundation stone for a place in the State League, Częstochowa Orla lost miserably in Radomsko 3:8 (1:3).

This was a match for entry into Class A of the Częstochowa Subdistrict.

Such a heavy defeat, once and for all, ruined Orlecia's chances for promotion into Class A and opened the way for Naprzód, whose match with Wysoka in Łazy, will undoubtedly be decided in its favour.

Polish Football Association travelling coach, Lt. Spojda, has been in Częstochowa for a week. He has been training Częstochowa footballers twice daily: in the morning, 12-15-year-old juniors, in the afternoon, older, advanced players.

Training takes place on the municipal pitch and the Marshall Pitch sudski Stadium. Both students and the football authorities are very satisfied with the Lt. Spodd's effective teaching method. He has gained great recognition.

The board of K.S. "Turyści" has suspended its Kielce District attacking player, Cichecki, for spreading false news and acting to the detriment of the club. This sensational news made a great impression of Czestochowa's sports world. Apparently, some factors have caused the intervention, in this matter, of the PZPN board in Warsaw.

It is worth noting that Cichecki intended joining Brygada in the coming day, The epilogue to this case will be very interesting.
