# The Executive of the Czenstochover Landsmanshaft of Montreal

The Czenstochover Landsmanshaft has gained a very favourable reputation in Montreal. This is a result of the activities that it conducts, thereby serving as an example for other *Landsmannschaften* and societies.

In order to conduct positive activities – such as:

- 1) continuing the traditions of the Częstochowa Jewish Community;
- 2) perpetuating the memory of the martyrs and the heroic struggle of Częstochowa Jewry against the Nazi regime;
- holding *yizkor* services in a worthy and reverent manner, on the days of mourning, in memory of the martyrs and heroes, who fell in sanctification of the Name [of God] and the People [of Israel];
- 4) seeking out and bringing to justice the Nazi murderers, may their name be obliterated, who gruesomely destroyed Częstochowa Jewry;
- 5) giving financial aid to our *landsleit* overseas, victims of the Nazi regime;
- 6) working for Jewish communal and cultural life in Montreal and helping it along, also financially; and
- 7) creating a familiar and comradely atmosphere amongst our *landsleit*, sharing the times of joy and, Heaven forbid, sorrow

- necessitates a group of people, an Executive, to manage the wide range of activities.

These individuals must:

- a) be able and competent to carry out such activities;
- b) possess deep feelings and sentiments for the tasks they must perform;
- c) be ready to volunteer as much time as needed
- d) willingly contribute financial means to make the accomplishment of these goals and tasks of the Society possible.

Who are the Executive Members?

In order to answer this question, we would need to write an entire book with each one's biography, communal activities, position in the general Jewish communal life, experiences during the Nazi epoch and current communal activities.

It is impossible to do so within the confines of this brief and unassuming essay. The sole aim of this short and modest article is to provide concise information as regards the office held by each Executive Member and his duties.

One characteristic, which unites all the Executive Members, is that they are all newcomers to Canada - all of them have lived through the Jewish wrangle, pain, troubles and suffering during the time of Nazi tyranny and, as such, have suffered themselves. They have an understanding for those who are, to this day, suffering and find themselves in need. Concurrently, they are the ones for whom the tasks and goals of the Society are a constituent part of their day-to-day mind and thoughts.



President Lajbke Jakubowicz

Lajbke Jakubowicz is President of the Society. His duties include representing the Society, taking part in meetings of all the committees, gatherings and functions. In cases of emergency, when it is not possible to call the Executive together at once, to deliberate with the Presidium and adopt the appropriate decisions in accordance with the constitution, goals and duties of the Society. Lajbke Jakubowicz carries out his duties with great devotion and responsibility.

Chairman Berl Ickowicz




Berl Ickowicz is Chairman of the Society> his duties include calling together the meetings of the Executive, preparing an agenda for the day together with the Secretary and chairing the meeting, coordinating the activity of the separate offices and maintaining contact with everyone [to ascertain] whether the activities, to which they have been entrusted, are carried out in accordance with the decisions adopted. We must stress the fact that Berl Ickowicz carries out his duties to perfection and is the suitable Executive Member for this office.



## Vice-Chairman and Vice-Treasurer Mendel Frydlender

Mendel Frydlender holds the offices of Vice-Chairman and Vice-Treasurer. He chairs the Executive meetings in the Chairman's absence and is one of the ones who sign the cheques. He maintains the documentation relating to the receipts [for donations] and bank meetings, at the same time executing all the tasks that every Executive Member is required to perform. He does this with great love, devotion, selflessness and idealism.



Harry Klein Treasurer

Harry Klein is Treasurer of the Society. His duties include not only collecting money and issuing receipts, but also formulating plans as to how to raise the funds. He concurrently performs the general functions of the Executive. A witticism has spread about him: "*His name is Small*<sup>1</sup>, *but his deeds for the Society are great*." He is the driving force behind the Executive's activities.

# Symcha Silver Secretary

Symcha Silver is Secretary. His duties include:

1) receiving all correspondence, reading it through and either reporting about it or reading it at the Executive meetings;

2) responding to the letters in accordance with the decisions of the Executive;

3) Sending out letters and invitations to members of the Society, regarding memorial services, general assemblies, fundraisers and all other functions.

Taking into account that this work entails a great deal of time, devotion and goodwill, forcing him to sit up until midnight following hard workdays, he truly deserves a hearty thank you and *yasher koyach*<sup>2</sup>.



Charles Konarski Recording Secretary

Charles Konarski is Recording Secretary. His duties include:

- 1) recording the minutes of the Executive meetings, general assemblies and all other functions; and
- reading out, at every Executive meeting, the minutes of the previous meeting, so that the Executive should be able to verify whether the decisions adopted were properly carried out.

Charles Konarski is not satisfied with just this office. He is active in all fields and particularly displays great understanding, heart and feeling to the allocation of financial aid to our impecunious *landsleit* overseas.

# Dr. Benjamin Orenstein General Secretary

Dr Benjamin Orenstein is General Secretary. His duties include:

- 1) representing the Society at conventions and conferences of a national, regional and local character;
- 2) maintaining written contact with *Częstochower* institutions and *Częstochower* personalities all over the globe;
- 3) editing all the Society's publications;
- 4) providing the appropriate incriminatory materials to the courts trying the Nazi killers who murdered Częstochowa Jewry;
- 5) appearing to speak at the memorial services;
- 6) giving reports of communal activities at the general assemblies and Executive meetings; and
- 7) being in charge of the Society's archives.

Dr Benjamin Orenstein holds a highly respected position in the historical research of the Holocaust era, and with his work, he is the chief historian of the Częstochowa Jewry's history.

#### Mojsze Altman Relief Committee Chairman



Mojsze Altman is Chairman of the Relief Committee – an office which is considered most important and honourable, as he and his committee are tasked with evaluating all appeals for financial assistance from impoverished *landsleit* overseas. Mojsze Altman is distinguished for his very good memory. He perfectly remembers all the *landsleit* and even the addresses where they lived before the War and the nicknames they had. He excels in his activities and takes part in all the work of the Executive. He is the right man in the right office.



### H. Rosenblum Cultural Committee Chairman

H. Rosenblum is Chairman of the Cultural Committee. His duties include preparing the programmes for all the functions. At the same time, he takes an active part in all the works of the Executive, performing his tasks in a conscientious manner. He is distinguished for his organisational capabilities.

#### Max Herszlikowicz Telephone Communications



Max Herszlikowicz holds the office of Telephone Communications. A system has been implemented whereby no invitations are sent to Executive meetings but, instead, telephone calls are made. This duty is conscientiously performed by Max Herszlikowicz. Very often, after a hard day's work, he sits for long hours on the telephone, informing all the Executive Members of the date and location where the meeting is to take place. It is his custom to ask first about health and family, recount something interesting and then notify regarding the session. Besides that, he participates in all the works of the Executive. He performs his duties conscientiously and with devotion.



### Simon Lerner Arrangements Committee Chairman

Simon Lerner is Chairman of the Arrangements Committee. His duties include all the arrangements for the annual balls held by the Society. He is concurrently the ticket champion - he sells tickets in very large numbers, reaching a total of sixty or seventy. Very often, it happens that he does not collect all the money, but he pays for them [himself]. His ticket sales immediately guarantee successful and well-attended balls.

### Aron Birenbaum Reception Committee Chairman





It very frequently happens that a sick person, who is lying and groaning with pain, meets the delegation, engages in conversation and is completely transformed, starting to chat and even to smile with joy. Besides that, Kamiński takes part in an entire array of the Executive's works and willingly contributes to the Society above his financial possibilities.



Mojsze Lewkowicz Audit Committee Chairman
